If there is a documented medical emergency, we will give you a credit towards riding lessons for your child. A \$25.00 fee is required to transfer registration to another camp. Registrations after that date will be made based on availability. Balance is due of the first day of camp.**

### REGISTRATION RULES

A non-refundable deposit of \$200.00 is required for each camp session to secure your spot, or you may pay in full at the time you register. Otherwise the balance is due on the first day of camp.

In the event of illness or emergency and the camper is unable to attend, we will refund your enrollment less your \$100.00 deposit if you have paid in full, or offer you riding lessons for your camper equal to the amount of the registration.

If you have registered for camp and wish to switch to another session, we will switch you to another session if a spot is available. If a spot is not available, you can apply your deposit payment to riding lessons.

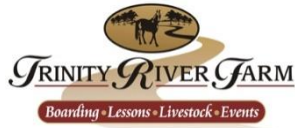

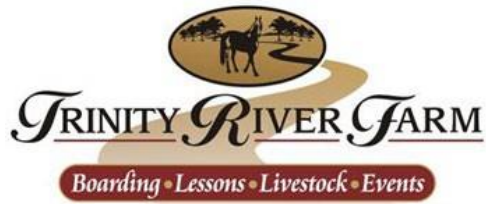

**SUMMER HORSE CAMP FACILITY RULES AND  
GENERAL RELEASE OF LIABILITY AND ASSUMPTION OF RISK**

This **Summer Horse Camp Facility Rules and General Release of Liability and Assumption of Risk** (“**Release**”) is made and entered into between \_\_\_\_\_, on behalf of myself and/or my minor child/legal ward, \_\_\_\_\_, (referred to as “**I**,” “**me**,” or “**myself**”), and/or any Related Guests (as defined below), and Trinity River Farm Equestrian Center, LLC, a Texas limited liability company, with offices located at 8375 Randol Mill Road, Fort Worth, Texas 76011 (“**Farm**”).

1. I desire to participate in equine-related activities which may include, but are not limited to: riding, training, caring for, viewing, buying, and/or boarding horses; student camps; parties or gatherings; riding lessons or instruction; general recreation; and/or any other activity or service provided by Farm, and/or to use Farm’s facilities, property, or equipment (the “**Activity**”). I understand that I am executing this Release on behalf of myself and/or any: child, ward, guests, friends, associates, personal representatives, heirs, next of kin, or assigns (“**Related Guests**”). I, on behalf of myself and/or any Related Guests, understand and acknowledge all applicable safety rules, procedures, and guidelines related to the Activity, which include the **Summer Camp Facility Rules** attached hereto as **Exhibit A**, and hereby agree to adhere to such rules, procedures, and guidelines, and any other policies set forth by Farm.

2. In consideration of being permitted by Farm to participate in the Activity, use Farm’s facilities and services, and the intangible value that I will gain by participating in the Activity, and in recognition of Farm’s reliance hereon, I, on behalf of myself and/or any Related Guests, agree to all the terms and conditions set forth in this Release.

3. I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, AM AWARE AND UNDERSTAND THAT THE ACTIVITY MAY BE A POTENTIALLY DANGEROUS ACTIVITY AND MAY INVOLVE THE RISK OF SERIOUS INJURY, DISABILITY, DEATH, AND/OR PROPERTY DAMAGE. I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, ACKNOWLEDGE THAT ANY INJURIES THAT I, OR ANY RELATED GUESTS, SUSTAINS MAY RESULT FROM OR BE COMPOUNDED BY THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF FARM, INCLUDING BUT NOT LIMITED TO, NEGLIGENT SUPERVISION, NEGLIGENT MAINTENANCE, NEGLIGENT INSTRUCTION, AND/OR NEGLIGENT EMERGENCY RESPONSE OR RESCUE OPERATIONS OF FARM. NOTWITHSTANDING THE RISK, I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY, DISABILITY, DEATH, AND/OR PROPERTY DAMAGE ARISING FROM THE ACTIVITY, WHETHER CAUSED BY THE ORDINARY NEGLIGENCE OF FARM OR OTHERWISE.

4. I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, HEREBY EXPRESSLY WAIVE AND RELEASE ANY AND ALL CLAIMS, NOW KNOWN OR HEREAFTER KNOWN, AGAINST FARM, AND ITS OFFICERS, DIRECTORS, MANAGER(S), OWNERS, MEMBERS, EMPLOYEES, AGENTS, AFFILIATES, SHAREHOLDERS, SUCCESSORS, AND ASSIGNS (COLLECTIVELY, “**RELEASEES**”), ON ACCOUNT OF INJURY, DISABILITY, DEATH, OR DAMAGE TO REAL OR TANGIBLE PROPERTY ARISING OUT OF OR ATTRIBUTABLE TO THE ACTIVITY, WHETHER ARISING OUT OF MY OWN ACTIONS OR OMISSIONS, OR THE ORDINARY NEGLIGENCE OF FARM OR ANY RELEASEES OR OTHERWISE. I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, COVENANT NOT TO MAKE OR BRING ANY SUCH CLAIM AGAINST FARM OR ANY OTHER RELEASEE, AND FOREVER RELEASE AND DISCHARGE FARM AND ALL OTHER RELEASEES FROM LIABILITY UNDER SUCH CLAIMS. THIS WAIVER AND RELEASE DOES NOT

**EXTEND TO CLAIMS FOR GROSS NEGLIGENCE, WILLFUL MISCONDUCT, OR ANY OTHER LIABILITIES THAT TEXAS LAW DOES NOT PERMIT TO BE RELEASED BY AGREEMENT.**

5. I, ON BEHALF OF MYSELF AND/OR ANY RELATED GUESTS, SHALL DEFEND, INDEMNIFY, AND HOLD HARMLESS FARM AND ALL OTHER RELEASEES AGAINST ANY AND ALL LOSSES, DAMAGES, LIABILITIES, DEFICIENCIES, CLAIMS, ACTIONS, JUDGMENTS, SETTLEMENTS, INTEREST, AWARDS, PENALTIES, FINES, COSTS, OR EXPENSES OF WHATEVER KIND, INCLUDING ATTORNEY FEES, FEES, THE COSTS OF ENFORCING ANY RIGHT TO INDEMNIFICATION UNDER THIS RELEASE, AND THE COST OF PURSUING ANY INSURANCE PROVIDERS, INCURRED BY/AWARDED AGAINST FARM OR ANY OTHER RELEASEES IN A FINAL JUDGMENT ARISING OUT OF, OR RESULTING FROM, ANY CLAIM OF A THIRD-PARTY RELATED TO THE ACTIVITY, INCLUDING ANY CLAIM RELATED TO MY OWN NEGLIGENCE OR THE ORDINARY NEGLIGENCE OF FARM.

6. I, on behalf of myself and/or any related guests, hereby consent to receive medical treatment deemed necessary if I (and/or any Related Guests) am injured or require medical attention during my participation in the activity. I, on behalf of myself and/or any Related Guests, understand and agree that I am solely responsible for all costs related to such medical treatment and any related medical transportation and/or evacuation. I, on behalf of myself and/or any related guests, hereby release, forever discharge, and hold harmless farm from any claim based on such treatment or other medical services.

7. I, on behalf of myself and/or any related guests hereby understand and acknowledge that farm reserves the right to refuse (or immediately terminate) services to me and/or any related guests at any time, with or without cause and with or without notice, during the course of an activity, or at any time during a summer horse camp. The reasons farm may refuse to provide services include, but are not limited to: violation of the rules and/or policies of farm, including the summer camp facility rules attached as Exhibit A hereto; the physical or mental condition or acts of any horse, person, or animal; acts and/or conditions of nature; and/or the inability or refusal by me or my related guests to follow the instructions of farm, its owners, managers, officers, or employees regarding acts or omissions of myself or my related guests that affect the management, care, welfare, or safety of a horse, any third parties, or the enjoyment by third parties of activities (including, but not limited to, summer horse camp or the use of farm facilities). I further understand and acknowledge that if farm terminates my or my Related Guests' participation in an activity or summer horse camp at any time for any reason that no refunds will be given.

8. This Release constitutes the sole and entire agreement of Farm and me with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. If any term or provision of this Release is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Release or invalidate or render unenforceable such term or provision in any other jurisdiction. This Release is binding on and shall inure to the benefit of Farm and me and their respective successors and assigns. All matters arising out of or relating to this Release shall be governed by and construed in accordance with the laws of the State of Texas without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction). Any claim or cause of action arising under this Release may be brought only in the federal and state courts located in Tarrant County, Texas and I hereby consent to the exclusive jurisdiction of such courts.

9. I, on behalf of myself and/or any related guests, have read and voluntarily sign this general release of liability and assumption of risk agreement, and understand that I am giving up substantial rights by signing it, and have signed it freely and voluntarily, and intend that my signature is a complete and unconditional release of all liability to the greatest extent allowed by law.

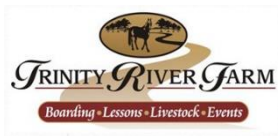

## **EXHIBIT A**

### **SUMMER CAMP FACILITY RULES**

1. Campers must follow all camp rules and polices found here and all other camp rules. Unacceptable behavior by anyone may result in dismissal from camp.
2. All persons must sign the Farm's General Release of Liability and Assumption of Risk form before participating in the summer camp program.
3. No riding without the permission and presence of a camp counsellor or the manager.
4. No jumping is allowed unless the rider is in a lesson and/or under the supervision of an instructor.
5. All riders must wear a helmet when mounted.
6. Campers must wear long pants and boots when riding.
7. No running, yelling, or rough-housing in the barn or around horses.
8. No throwing balls or other objects around horses.
9. To avoid the risk of being kicked, do not run up to or behind a horse.
10. Do not feed any horse without the owner's consent. Feed treats from a bucket, not by hand, and only with permission.
11. Absolutely no running after, chasing, or hitting any horse or other animal.
12. No children other than campers are allowed in the barn unless accompanied by an adult. If the barn is crowded, please do not enter.
13. All guests in the barn must have proper footwear, meaning close-toed shoes.
14. Never walk away from a horse that is not tied up. Always attend to your horse.
15. Keep all gates to horse and livestock areas closed.
16. Riders should not mount a horse unless an instructor is present.
17. Campers are responsible for putting away all supplies and equipment after use, including saddles, bridles, brushes and other supplies.
18. Campers are responsible for learning to clean up after their horse. Please pick up and dispose of all trash.
19. Campers are responsible for cleaning up the area after projects.
20. Campers are responsible for cleaning up the camp area after meals and snacks.
21. Campers will treat other campers with courtesy and respect.
22. Campers will behave in a respectful manner towards camp counsellors and will follow their instructions at all times.
23. Campers will not go into fenced in livestock areas without permission.
24. Campers will take care of their horses first after riding.
25. Campers are responsible for keeping track of their own belongings at all times.
26. No glass containers on the property, please.
27. Please turn off lights in the rest rooms.





## SUMMER HORSE CAMP INSTRUCTIONS

### Dear Parents,

Please read the following information carefully concerning your child's horse camp registration and our operating procedures. We are delighted that you have chosen us, and we are looking forward to working with your child.

### DOCUMENTS-

You will receive the following documents. **Please complete them and bring them the first day of camp.** Please review the Camp Rules document with your child.

1. Authorization to Obtain Medical Treatment form.
2. General Liability
3. The registration form if you have not registered on-line.

### PAYMENT-

You will need to **pay your balance** if you have not already done so on the **first day of camp**. We accept cash, check, PayPal, and credit card. We will process your payment with check-in.

### CAMP HOURS AND PARKING

Camp hours are 9 AM to 2 PM. Please plan to arrive at least 20 minutes early the first day for processing. If you are arriving late, please let us know so that we can plan accordingly. There is a gate at the facility entrance. You will need to open it, drive through and close behind you. If at all possible, we will have an attendant to assist at the gate. Parking is available near the covered pavillion across from the outdoor arena towards the back of the property.

### FIRST DAY OF CAMP YOU SHOULD BRING:

1. Camp documents including medical release and liability release forms.
2. Camp balance if not previously paid in full.

### ATTIRE:

1. Students must have their own approved riding helmet. (Not a bike helmet.)
2. Long pants (not capris).
3. A low-heeled boot (not Western boots). English Paddock boots can be purchased at a reasonable rate from Dover Saddlery in North Dallas, or over the Internet.

### HORSE SHOW:

We typically hold a "horse show" so that parents can see their child's progress on the last day of all 5-day camps at the end of the camp day. Please ask your camp counsellor for details.

## THINGS TO SEND WITH YOUR CHILD DAILY-

1. A change of clothes for afternoon activities: shorts and tennis shoes.
2. A lunch and snack.
3. Refillable water bottle.
4. Sunscreen if desired. (we will primarily be in the shade)
5. Horse treats are always welcome! Carrots, apples, granola bars.

## SUPPLIES FOR CAMP ACTIVITIES-

Since the onset of Covid-19 in 2020, we have modified some of our camp practices. In order to reduce sharing of certain activity supplies, we are asking parents to bring a box labeled with your child's name and phone number, with the following supplies: (Note:many of these things you probably already have at home!)

- Felt tip drawing markers
- Colored pencils\*
- Crayons \*
- 2 sharpened pencils
- School scissors
- Elmer's school glue.
